Malaysia, Nov 15: Malaysia is gearing up to reopen its borders to international visitors from January 1 at the latest. This is as per a government advisory council, which added that this move comes as the country seeks to revive its failing tourism sector.

IRCTC goes veg on select routes



J&K's first 'tourist village'

Jammu, Nov 15: The first tourist village 'Zoogu-Khairan' in Jammu and Kashmir's Budgam was inaugurated on Saturday. District development commissioner (DDC) Shahbaz Ahmed Mirza inaugurated the village and said the area has vast potential to emerge as a new tourist destination.

This is a big occasion for Zoogu-Kharian Village and its adjacent habitations as this day mark the new beginning of socio-economic upliftment of this area," he said.



"The area has been brought on a tourism map, which shall go a long way in shaping the future of Zoogu-Kharian," the development commissioner said, according to the department of information and public relations, Jammu and Kashmir.

"Faith and efforts together made this day possible, the public of this area will see the difference in the near future," he said.

Chennai, Nov 15: The IRCTC will promote "vegetarian-friendly travel" by getting some trains "sattvik certified", especially those running on routes connecting religious sites, according to a statement by Sattvik Council of India which is involved with the certification.

No one from the IRCTC, the catering and tourism arm of the Indian Railways, was available for comment.

According to a press release issued by the Sattvik Council of India, it has tied up with the Indian Railway Catering and Tourism Corporation (IRCTC) to introduce services that fits the requirements of vegetarians and promotes vegan travelling to holy destinations.

The IRCTC runs the Vande Bharat Express which travels from Delhi to Katra. It will be certified as 'sattvik', it said.

The Sattvik Council of India said it will launch the 'sattvik' certification scheme along with IRCTC on November 15. It will also develop a handbook of vegetarian kitchen jointly with the IRCTC.
